



Registration of Interest for SJM Five-a-side Football Friendly Fans Meet-and-Greet Event

1. How to Participate:

- 1.1. Customer may register their interest for the Meet-and-Greet via SJM Resorts' official website if they have purchased tickets for the "SJM Five-a-Side Football Friendly" (one registration per ticket).
- 1.2. Each customer shall enter personal information and upload a screenshot of the confirmation email or SMS, or a picture of the physical ticket, to register for the meet and greet.
- 1.3. The confirmation email or SMS must be issued by an officially authorized ticketing platform.
- 1.4. The valid period of registration of interest period is from 13 May 2024, 6:00 P.M. to 15 May 2024, 11:59 P.M.
- 1.5. Registration must be completed online within the registration of interest period.
- 1.6. Authorized ticketing platform: MacauTicket.com Kong Seng, Trip.com, Damai, Cityline.

2. Registration of Interest Process

- 2.1. Customer may register their interest in attending the Meet-and-Greet by filling out a form online via SJM Resorts' official website.
- 2.2. Incorrect registration information may lead to failure of eligibility for the Meet-and-Greet.
- 2.3. SJM will not be liable for any technical malfunctions, errors or delays in the registration process.
