

## **Terms and Conditions**

- 1. By registering to the workshop, the participant (or the parent/ guardian of participant under 18 years of age) hereby confirms that s/he agrees to all the terms and conditions listed below.
- 2. For the participants' age requirements of each workshop, please refer to the official website of "GLP Arte".
- 3. Participants will receive ONE admission ticket to join PEANUTS-themed workshop via the following ways:
  - 3.1 Guest who purchased the designated "Snoopy Winter Holiday Hotel Package" will be entitled to receive ONE workshop admission ticket of "PEANUTS-themed Workshop" at GLP Arte service counter with the booking registered name. The tickets will be available at a first-come first-served basis.
  - 3.2 Guest present the receipt with spending upon MOP \$2,000 or above in Grand Lisboa Palace Resorts Retail or F&B outlets within the week before the "PEANUTS-themed Workshop" (including the day of the workshop before 4pm), will be entitled to redeem ONE workshop admission ticket at GLP Arte service counter. The tickets will be available at a first-come first-served basis.
- 4. Workshop vacancies are limited and there is no replaceable session or exchange once the admission ticket has been redeemed.
- 5. Participants must present the original ticket at the workshop entrance. Ticket will not be replaced or accepted if lost, damaged or stolen.
- 6. Participants need to register 5 minutes before the workshop at the activity venue, admission will be stopped 15 minutes after the workshop starts.
- 7. If the workshop is cancelled by SJM, (including "PEANUTS-themed: Wool Felt Hat Workshop", "PEANUTS-themed: Origami Workshop"), the ticket will be exchanged for another workshop ticket within 60 days.
  - 7.1 There is no exchange if the workshop cancellation occurs after 15 minutes upon the commencement of the relevant session.

- 9. Participants are solely responsible for their own belongings, SJM will not assume liability for any damage to or loss of property.
